This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e Upgradation to Senior Secondary Level as per details given below :

The school is directed to ensure that :

1	The total number of section of the school after upgradation, shall be restricted to 20 (As per prescribed dimension) out of which, not more than 1/3rd sections may be used to run Senior Secondary classes and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2	The total number of section of the school shall be restricted to 20. The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed. Further, increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws and subject to the availability of room size of greater than 500 sq ft. The student strength in sections of < 500 ft size shall be restricted to 32 as per bye laws.
3	The school has placed temporary wedges outside CWSN toilets which have no hand rails and are dangerous for CWSN to navigate. Some toilet cubicles do not have enough room to navigate a wheel chair/walker. The school shall make the CWSN toilets properly accessible , on all floors, as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.
4	IC has reported a ramp to access the upper floors in one building block, but the same is not seen. The school shall make provision for ramps/lifts to access the upper floors in both blocks as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.
5	It is seen in the video that a part of the school, near the play ground does not have a concrete boundary wall, only a plant hedge. The school shall construct a concrete boundary wall of 6 ft height , enclosing the school on all four sides, within 3 months and submit compliance on SARAS.
6	Failure to submit compliance on above mentioned points within prescribed time shall invite financial penalty against the school.
7	The school shall get all the mandatory certificates renewed periodically.

8	The school is directed not to remove the mandatory disclosure section from its website and the videography link of the inspection /infrastructure from YouTube.
9	The school shall conduct training of its teachers with CoE Chennai within 3 months and submit the compliance.
10	The school is advised to follow the SoPs issued by the Board in respect of labs, library and sports facilities.

The above sanction is subject to fulfillment of following conditions:-

- The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
- The school to renew mandatory certificates from time to time.
- The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.

“The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms”.
