


- IV. To help talented students in rural areas to achieve distinction in their chosen field of study and research.

- VIII. To offer scholarships, studentships and other beneficial services to both the religious and linguistic minority students/applicants in order to enable them to secure good education in life.



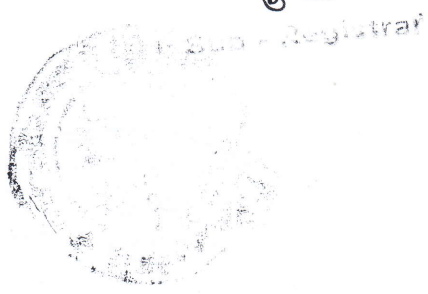

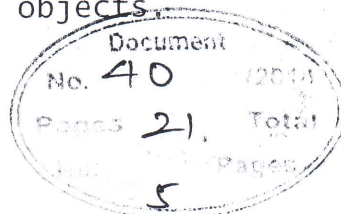

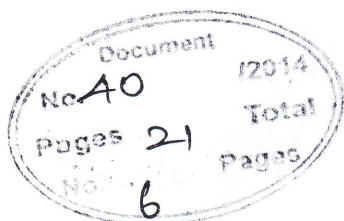


- XV. To run orphanages, hospitals, educational institutions under the trust and run the same as part and parcel of the Trust.




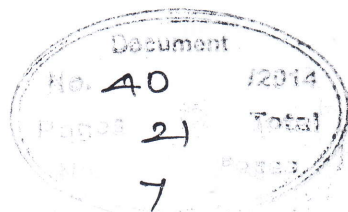
4. BOARD OF TRUSTEES :

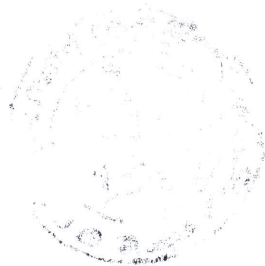

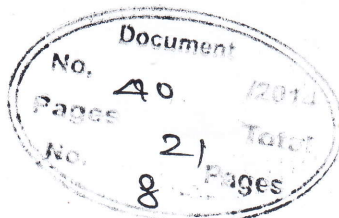

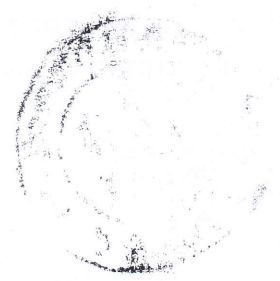

6. POWERS OF THE BOARD :

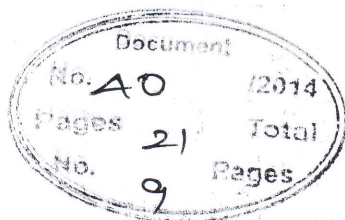
- I. All the properties, assets and funds of the trust to be acquired in future shall be held in such manner, as the board shall direct the same, as the board shall deem fit.

- IV. To sell, lease or otherwise dispose of any immovable properties, assets and goods of the Trust to be acquired in future.





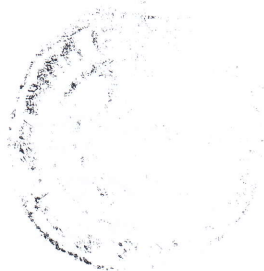

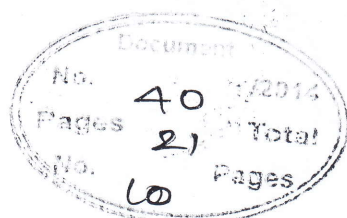





- V. To open accounts with one or more bank in the name of the Trust which shall be operated by the Managing Trustee and deposit the monies of the Trust in such accounts.

- i. The Trustees shall maintain or cause to be maintained true, fair and correct accounts of all income and investments thereof and all outgoings and expenses.

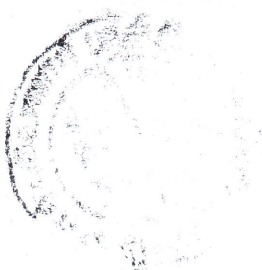

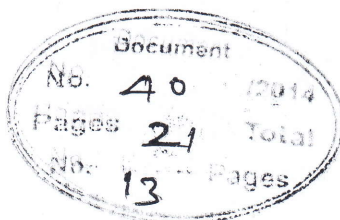
9. NOTICE OF MEETING :

12. The trust deed shall not be amended without the prior consent of the Director of Income Tax (exemption).


